Data gathering for educational initiatives for young people (article 16, Italian Law n. 222/85) promoted and planned by Pastorale Giovanile della Provincia Agostiniana d'Italia for the season 2019-20.

Policy

Considering what is included in art. 91 of EU Directive 2016/679, the use of the data you gave us through the form is subjected to the CEI General Act "*Disposizioni per la tutela del diritto alla buona fama e alla riservatezza dei dati relativi alle persone dei fedeli, degli enti ecclesiastici e delle aggregazioni laicali*" issued on May 24th, 2018.

Based on articles 6 and 7 of the CEI General Act it is specified that:

- a) The data controller is the Pastorale Giovanile della Provincia Agostiniana d'Italia, based in Via della Scrofa 80 – 00186 Roma, represented by father Michele Falcone O.S.A., as pro tempore appointed manager;
- b) To contact the data controller, the email cascia@santarita.info can and should be used;
- c) The data given by the interested party are required and will be managed solely to plan educational initiatives dedicated to young people, promoted by Pastorale Giovanile della Provincia Agostiniana d'Italia;
- d) During those activities photographic and video material may be produced with the only purpose of documenting the life of the community and will be kept in church offices solely for historical documentation;
- e) Materials described in letter d) may be published by means of periodicals, websites and social network where participating churches have profiles;
- f) Pictures will be taken during public moments of community life, if you refuse to give consent for the publishing, it will be your concern not to participate in (or, while ensuring adult supervision, if you are a legal guardian of a minor, to explain him/her to avoid) situations where pictures or video are clearly taken, such as group photos;
- g) The data given by the interested party will not be communicated to third subjects, with the exception of participating church offices and other juridical institutions, if and when expected by canonical laws, which would be joint data controller;
- h) The data given by the interested party will be kept for as long as necessary to end the activities explained in letter c), if and when expected by canonical laws; some of the data may be kept longer than that, if and when it will answer a specific need by Pastorale Giovanile della Provincia Agostiniana d'Italia or by participating churches;
- i) The interested party may anytime ask Pastorale Giovanile della Provincia Agostiniana d'Italia (see letter b)) to access his/her data, to modify or to delete them, to reduce the range of this authorization or to oppose to the use of those data; that request will be honored by all joint data controllers. If revoked, the lawfulness of previous usage will not be affected;
- j) The interested party may lodge a complaint to the Supervisory Authority;
- k) The refusal to process related to letter c) precludes the acceptance of the registration request.
